Gordon first contends that the district court erred in refusing to suppress the cocaine seized by the police. Gordon further argues that the district court erred in overruling his objection to the Government's expert testimony regarding the type of bag in which the cocaine was discovered. Gordon finally contends that there was insufficient evidence to support his conviction. After reviewing the record in this case, this Court affirms the conviction but remands for resentencing. I. A. 2 On June 12, 1989, at approximately 3:00 a.m., Louisiana State Police Officer Mark Broussard was patrolling Interstate Highway 20 in Bossier Parish, Louisiana. Officer Broussard observed what he believed to be a narcotics transaction taking place in the median of the highway between two vehicles. Officer Broussard stopped to investigate the situation and observed two men standing in the median of the highway, a briefcase between them. Officer Broussard approached the two men and immediately observed a sawed-off shotgun lying on the ground next to the driver's side of a brown station wagon, although not in plain view. After the men were ordered to lie on the ground, Officer Broussard conducted a pat-down search for weapons, during which time he felt a plastic baggie in Gordon's pocket. Officer Broussard retrieved the baggie and found that it contained a brown powdery substance that field tested positive for cocaine. Officer Broussard then read the
